# Philadelphia Federal Reserve Bank VP Talks about the Economy

More than 70 business people attended the January 20 meeting of the Bridgeton Area Chamber of Commerce held at noon at The Green Olive Restaurant in Hopewell Township. As members and guests gathered for the meeting, they were able to catch some of the presidential inauguration ceremony on a screen at that time.

Guest speaker William Stone, First Vice President of the Federal Reserve Bank of Philadelphia, talked about the state of the economy from his perspective and his outlook for the depth and severity of the national and worldwide recession. Stone said there is a combination of economic events happening all at the same time that he has not seen in his decades long banking career.

"While the recession may have started early in 2008, the country's gross domestic product (GDP) statistics slowed to 1 percent growth in the first quarter of 2008 and rose to nearly 4 percent growth in the second quarter due mainly to injection of federal tax rebates into the economy," explained Stone.

The GDP declined by one-half percent in the third quarter and dipped dramatically by nearly 6 percent in the fourth quarter. Consumer spending reacted to the growing bad economic news by declining by 1.1% in the fourth quarter. In all fourth quarters dating back to 1995, consumer spending rose in this quarter of the year.

If you were looking for some good news from the Philadelphia Federal Reserve Bank on the economy, you can stop reading now. Stone presented employment statistics showing employment peaked at the end of 2007 and more than 2.5 million jobs have been lost since then through the end of December 2008.

Stone added, "Job losses in the previous three recessionary periods averaged 150,000 per month. In 2008, the losses averaged 200,000 each month. Firms are cutting jobs sharply as 2009 begins and we don't see job growth resuming until middle of 2010 if businesses are convinced the recovery is in place."

Stone said the housing market will bottom out in 2009 with an estimated .66 million private housing units to be started. 2010 will see improvement to just over 1 million units expected to be started.

For the record, since this Chamber meeting, employers slashed another 598,000 jobs off of U.S. payrolls in January, taking the national unemployment rate up to 7.6%. New Jersey's unemployment rate is also up. The jobless rate in Cumberland County jumped 1.7 percentage points to a double-digit jobless rate of 10.4 percent in December, the second highest in the state.

## Free Workshop on NJ Business Stimulus Program

The Bridgeton Area Chamber of Commerce joins Cumberland County Planning and Development Department and several other business organizations in promoting a free business workshop on Friday, February 27th, 9:00 a.m. to 12:00 p.m. at the Cumberland County College, Luciano Conference Center in Vineland.

The free program is designed to provide information on two new programs available to businesses in Cumberland County and throughout New Jersey that are part of the Governor's and Legislature's business stimulus effort.

Known as "Invest NJ", the program includes a jobs creation component including \$3,000 grants per each new full-time job created, up to \$500,000 per applicant. It also includes a

grant of 7% of a qualified capital investment, up to \$1 million per applicant. The Main Street Assistance part of the program features bank term loan participations and/or guarantees and line of credit guarantees to help support borrowing for working capital, fixed assets, refinancing of debt.

Joe Constance and Harris Friedberg from the New Jersey Economic Development Authority, which is managing these programs for the State, will make the presentation. They will give you the details on how your business may take advantage of these grant and loan programs.

The other co-sponsors are Cumberland Development Corporation, Cumberland County College, City of Bridgeton,

Greater Millville and Greater Vineland Chambers of Commerce, Cumberland Salem Workforce Investment Board and Cumberland County More to Offer.


