Business Categories Criteria:

- ◆ Business must be in business for at least 7 years
- ◆ Business must have a commitment to the economic community
- ◆ Business must have community awareness and involvement
- ◆ Business need **not** necessarily be member of the Chamber
- ◆ Awardees cannot be honored twice within a 5-year period

Criteria for Francis Sharp Award: Respected individual of the community. Awarded for meritorious service to the greater Bridgeton Area promoting economic progress and contributing to the quality of life of the community at large. One who maintains high ethical standards in conduct of business, civic and community activities.

The Gary Simmerman Leadership Award: An individual, group of individuals or an organization that has demonstrated outstanding leadership in the past year or so, that has made a positive impact on the Chamber, an organization and/or the community in general.
